Breast Cancer Patient Protection Act

The Breast Cancer Patient Protection Act of 2005 would allow a woman and her doctor to decide whether she should recuperate for at least 48 hours in the hospital or whether she has enough support to get quality care at home following this emotionally and physically difficult surgery. It does not mandate a hospital stay. The bill is sponsored in the Senate by senators Olympia Snowe and Mary Landrieu and in the House by representatives Sue Kelly and Rosa DeLauro.

Representative DeLauro first proposed this bill in 1996, after Connecticut physician Kristin Zarfos, M.D., brought the ever-increasing practice of "drive-through" mastectomies to her attention. Though previous versions of this legislation have stalled in committee, the Breast Cancer Patient Protection Act of 2005 (S 910/HR 1849) has 185 bipartisan cosponsors in the House and 17 in the Senate. The House bill is currently in the Subcommittee on Employer-Employee Relations.

Although the Divers possessed the glamour of the Murphys, the tragedy of the Divers' marriage more accurately reflected Fitzgerald's own marriage to his wife Zelda, and not that of the Murphys.
