Remembering E. Anne Taylor

Branch condolences are extended to former member Susan Taylor (1996-2003) and her two brothers upon the death of their mother E. Anne Taylor, September 29th, a day before her 87th birthday. Anne first joined our branch during the 1957/1958 year and held membership for most years until 1981. Rejoining in 1991/1992, she was a member until the current year.

The following was contributed by Susie Leonard:

Anne frequently related a story about her mother when she was a teacher. When her mother, Betty, became pregnant with Anne, the superintendent of schools told her that she could not longer work as a school teacher. Betty replied that the superintendent and all of the male teachers must have been virgin births. After that remark, Anne's mother was reinstated in her teaching position.

Anne, Susie Taylor, myself, and my mother would get-together occasionally at the Jazz and Java coffee shop to drink coffee and talk about politics or relate stories of the past to each other.

Anne was a journalist for 14 years for the Sun Telegram newspaper. She wrote police reports, about fires, but she also wrote about societal issues in San Bernardino County. During this time, she asked her boss for pay equal to the male journalists. The Sun Telegram granted her equal pay.

As part of volunteer service, she raised money for the March of Dimes. Anne, along with her daughter, Susie, walked door-to-door in diverse neighborhoods to collect dimes. This experience replicated one Anne had with her mother, Betty. Anne, by doing this, wished to communicate as did her mother, that all groups of people in society mattered, that they need not be ignored to help society, and that they had children who had birth defects, too. In addition to her March of Dimes volunteer work, she and six other women in AAUW established the first library for Orangewood High School. They collected books and implemented a system for borrowing books.

As an artist, Anne created photography and ceramics. She won awards for her photography.

Susie Taylor said, "I am proud of my mother, she lived life supporting equal rights for everyone." We will always remember Anne for her passion for political activism; involvement in helping support education for others; pursuing activities that created equal rights for all; her sense of humor and artistic expression.

For the latter group, several times she was most generous in offering her hospitality to meet in the older home she had so beautifully restored and decorated, and of which she was most proud.

She was a wonderful interior decorator, combining her training with the special talents and skills with which she was born. She loved and appreciated beauty. Elise worked as a decorator for Home Depot and other stores in this area.

She was an active member of Assistance League, Red Hat, Old House Group, and worked regularly at the Redlands Glass Museum. Elise was a kind and generous friend who could be counted on to help others.

She was a member of our branch 1976 through 1979, and later rejoined in September of 2001 where she held current membership.

A reset can erase the memory and restore the phone to its original factory condition. User manuals typically include directions for the process. Also, you can consult the Cell Phone Data Eraser, a free service. The website for this service, www.recellular.com, includes a link to downloadable instructions for erasing data from hundreds of cell phone models.
